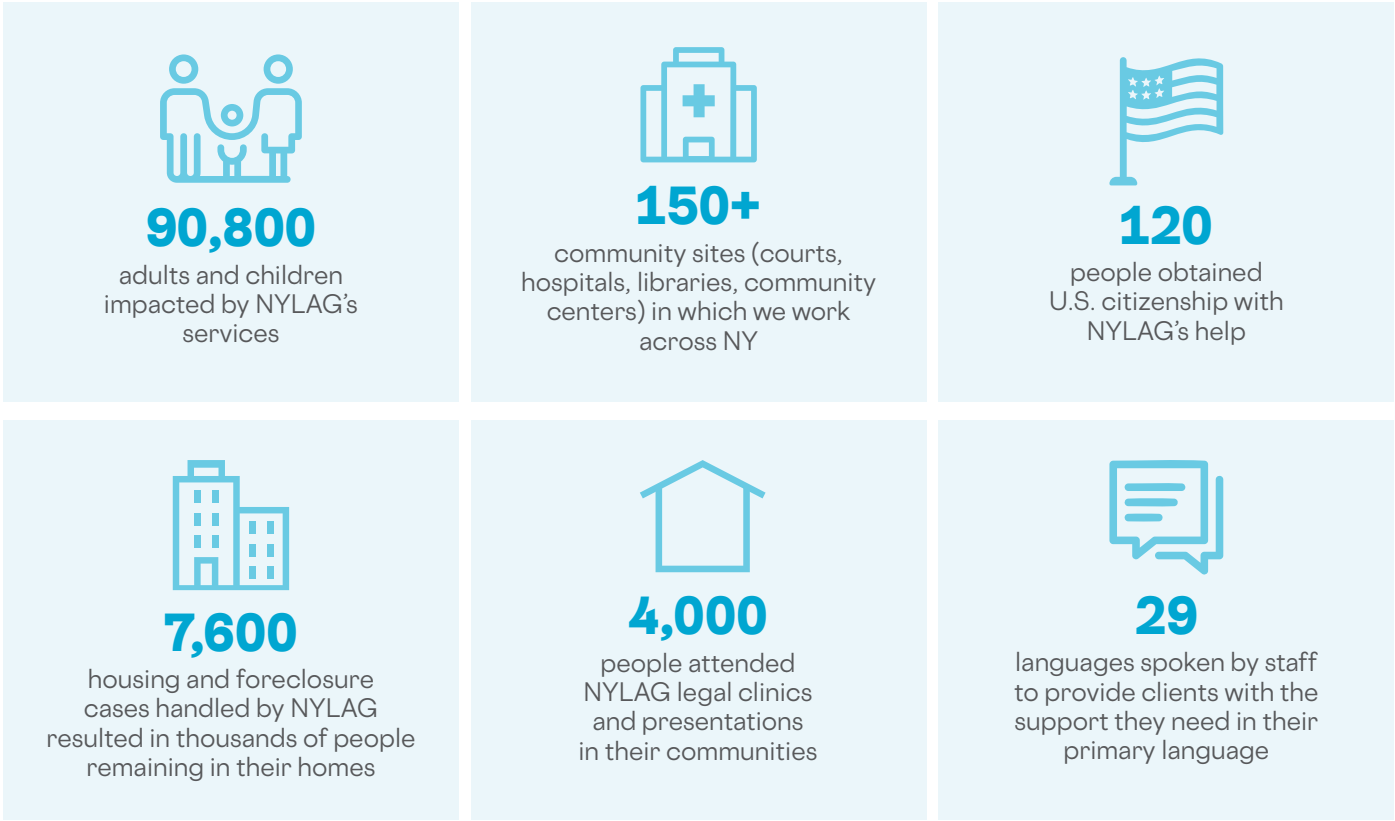

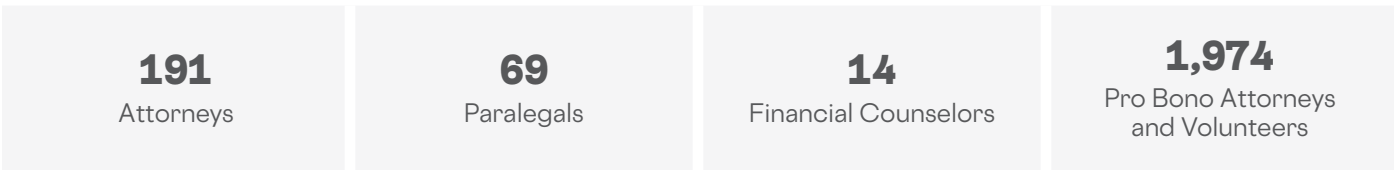

2018/19 HIGHLIGHTS



NYLAG DRAFTS NEW LAW TO HELP IMMIGRANT PARENTS

JULY 2018 - The new Standby Guardianship law—which NYLAG drafted with pro bono partner Greenberg Traurig—is implemented. It allows immigrant parents to designate a trusted guardian for their children should they be separated due to immigration enforcement.



NYLAG'S SPECIAL LITIGATION HELPS SENIORS REMAIN AT HOMES

DEC 2018 - NYLAG obtained final approval of a settlement bringing relief to people whose Medicaid-funded home care services had been wrongfully reduced or terminated, allowing hundreds of elderly clients to remain safely in their homes. (*Caballero v. Senior Health Partners*).



TAILORING FINANCIAL COUNSELING FOR PEOPLE WITH DISABILITIES

DEC 2018 - NYLAG was awarded a major grant for a new partnership with EmpoweredNYC, a multi-agency collaboration, to provide tailored financial counseling services to people with disabilities and their families.



A NYLAG CLASS ACTION PROVIDES RELIEF TO DEFRAUDED STUDENTS

MAY 2019 - NYLAG defeated the U.S. Department of Education's motion to dismiss a class action aimed at redressing the Department's failure to notify students of a defunct for-profit school of their right to discharge their loans. (*Queros v. Devos*)



NYLAG DOUBLES DOWN EFFORTS ON RACE EQUITY AND INCLUSION

AUG 2019 - Caprice Jenerson was named as NYLAG's first-ever Chief Equity & Inclusion Officer, an outgrowth of our strategic plan, which includes a commitment to diversity, equity, and inclusion.



UNVEILING A BOLD NEW NYLAG VISUAL IDENTITY

SEPT 2019 - Because of NYLAG's exponential growth, and to better reflect NYLAG's mission and values, NYLAG unveiled a new visual identity, including a new logo and website, to strengthen how we communicate our lifesaving and vital work.



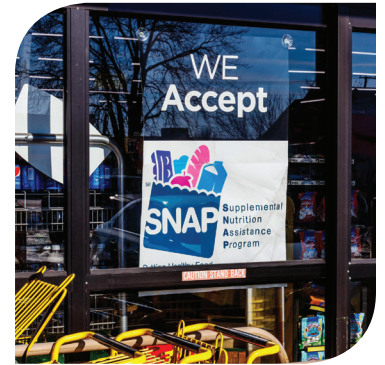
NYLAG ATTORNEYS HELP DECREASE CITYWIDE EVICTIONS

JAN 2019 - New York City announced a 37% decrease in citywide evictions since 2013 – a huge victory that could not have been possible without NYLAG’s dedicated housing attorneys.



LOOPHOLES THAT ALLOW SCAM AGAINST VETERANS IS CHALLENGED BY NYLAG

JAN 2019 - NYLAG testified to the NYS Legislature against loopholes that allow for-profit schools to target vets for their education benefits. In May, NYLAG sued U.S. Dept. of Veterans Affairs for failing to release related public records.



NYLAG DENOUNCES INCREASED RESTRICTIONS ON WORK REQUIREMENTS FOR SNAP BENEFITS

APRIL 2019 - NYLAG submitted comment on USDA’s proposed rule, outlining how it will only increase the number of people facing hunger in the U.S.



IMMIGRANTS WITH ORDERS OF REMOVAL CAN NOW TURN TO NYLAG

SEPT 2019 - In response to dramatically increased immigration enforcement, NYC and NYS created a Rapid Response Legal Collaborative, which includes NYLAG, to represent immigrants detained by ICE facing imminent removal.



LOOKING AHEAD

In 2020, NYLAG will honor its 30th year of providing free legal services to people experiencing poverty.

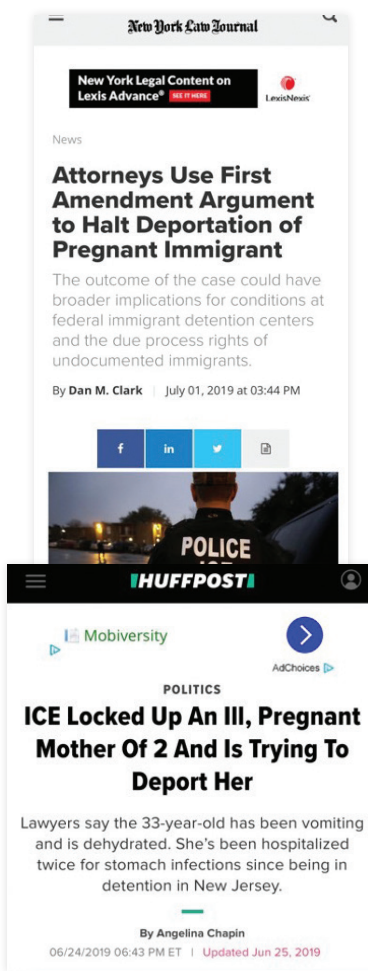

NYLAG'S CASE OF A PREGNANT IMMIGRANT MOM DETAINED BY ICE CAUSES A NATIONAL MEDIA FRENZY

Alma Santiago—a pregnant woman with two young U.S. citizen children—was detained by ICE in April 2019. While in custody, she experienced a medically difficult pregnancy and was retaliated against when she demanded proper care. ICE isolated Alma and sought to deport her immediately.

After an emergency stay was denied, our lawyers, along with pro bono co-counsel Greenberg Traurig and NSC Community Legal Defense, shifted gears and filed an emergency request in federal court to prevent ICE from precipitously deporting Alma. The Court granted a Temporary Restraining Order. The Department of Homeland Security subsequently agreed to release Alma from ICE detention. Her story was met with a heartwarming wave of public support, and we were at LaGuardia Airport to welcome her home.

Lestiel is a mom of two, a Gulf War veteran living with a disability that prevents her from working, and a survivor of military sexual assault. Three NYLAG attorneys - a veterans' benefits expert, a housing lawyer, and a disability advocate - worked with Lestiel to erase her student loan debt, access treatment for her PTSD, stabilize her rent, and obtain the disability benefits to which she was entitled.

BEHIND THE NUMBERS: QING, BRIAN, AND FAITH

Behind each of the 90,800 people we helped last year is a story of hardship, a will to persevere, and a NYLAG attorney who helped someone in need get justice.

Qing survived years of domestic abuse. Even though she had an order of protection against her ex-husband, he was stalking her and their kids. Qing, who spoke limited English and was wary of the American legal system, felt comforted when NYLAG was able to connect her with an attorney who speaks Mandarin, one of 29 unique languages NYLAG staff speak. After nearly two years of proceedings, in which Qing was forced to face her abuser in court, NYLAG helped Qing win sole custody of her children, child support, a final order of protection, and a judgment of divorce.

While serving in Iraq, Brian faced near-death experiences and saw close friends killed. He developed PTSD, painful flashbacks, and suicidal thoughts. Brian applied for VA compensation benefits to which he was entitled, but was denied after he failed to appear at an exam for his PTSD. Like many veterans, he missed it because he felt paralyzed by the thought of recounting his traumatic military experience. NYLAG compiled new evidence to support his claim for service-connected compensation and prepared him for the exam. As lawyers trained in trauma, we know how important it is for trauma survivors to know what to expect. With NYLAG’s help, Brian was finally awarded benefits needed to address his PTSD.

Faith is the mom of two children with nonverbal autism who were not receiving the education services to which they were entitled. Faith says she was “...unsure the future direction [her] kids’ life would take without the necessary helped they needed in school to progress in life.” Desperate, she turned to NYLAG. NYLAG took the case, knowing that Faith was ready to do whatever it took to fight for her kids. Together, we won the services Faith’s children need to make meaningful educational progress. Every single year we will fight, which is what must be done in the education-advocacy realm. Faith’s children have made huge progress, and she feels hopeful about their future.

NYLAG attorney Crystal Fleming helped 8-year-old Tomas gain asylum on the grounds of the violence he experienced in his home country. Crystal oversees NYLAG's Special Immigrant Juvenile (SIJ) work, helping children who have survived abuse, neglect, or abandonment, the ability to seek lawful permanent residence in the U.S

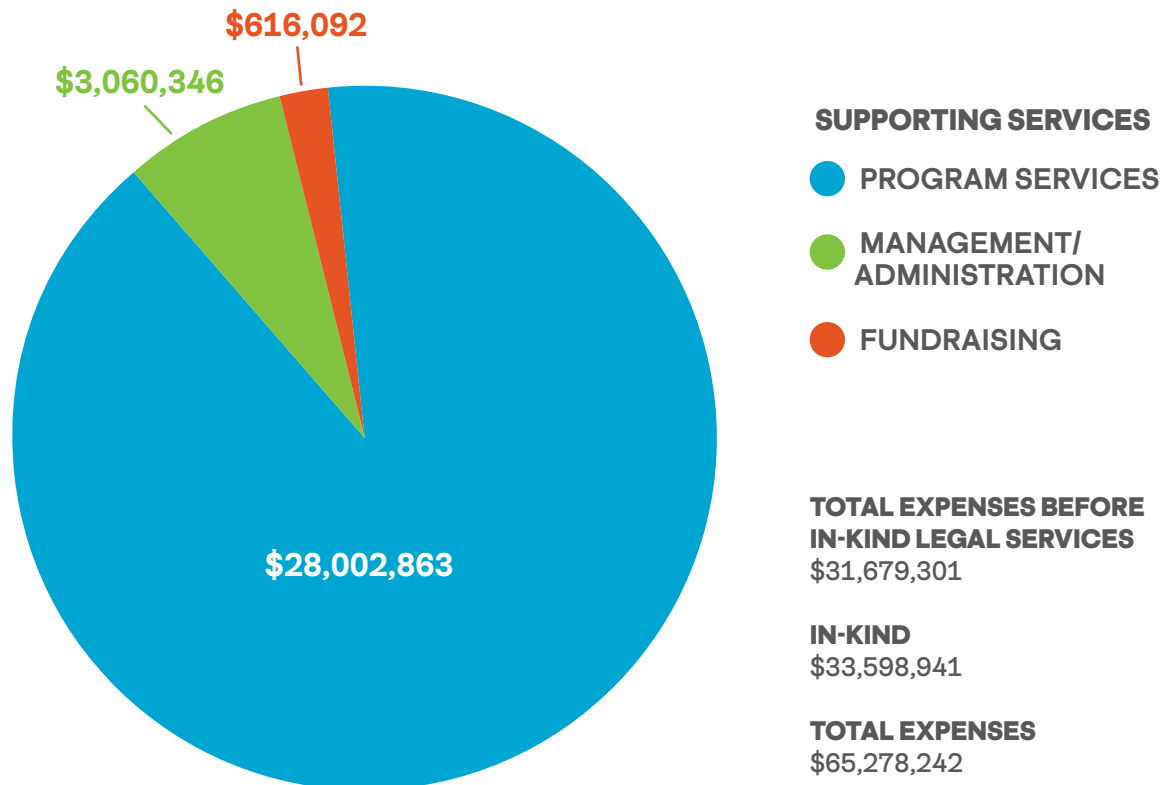
